Contestant Rules and Regulations

- Participants must provide their own ingredients, grills and cooking utensils necessary to prepare and cook their dish.
- Park opens at 8:00 am. All participants should be set up by 11:30 am
- Contestants must adhere to all health, electrical, fire and other codes whether city, county, state or federal.
- Contestants must have a fire extinguisher.
- Contestants must provide at least 20 lbs of their dish for crowd sampling to be considered for the People's Choice Award.
- **CONTESTANTS MUST USE SAMPLE CUPS PROVIDED TO THEM BY THE CARIBBEAN COOK-OFF FOR CROWD SAMPLING. VIOLATION OF THIS RULE WILL DISQUALIFY YOU FROM THE COMPETITION.**
- **Contestants may not sell to the public unless they pay the required vendor fee. The vendor fee for contestants is \$250.00 ANY VIOLATION OF THIS RULE AUTOMATICALLY DISQUALIFIES YOU FROM THE COMPETITION AND YOU WILL BE REMOVED FROM THE EVENT.**
- Contestants who decide to be vendors must submit vendor form with this application.
- Each dish may be presented with an appropriate accompaniment and garnish of your choice.
- All contestants must wear aprons and loose hair should be pulled back.
- All contestants must maintain a clean cooking area.
- Food must be displayed in an approved container provided by the contestant then numbered by judging officials. Three (3) judges will judge the dishes.
- Spaces are approximately 10' x 10' in size.
- **VEGETARIAN DISHES SHOULD NOT CONTAIN ANY FORM OF MEAT. Tofu and soy products are acceptable. This category is a dish of your choice.**
- Some form of cooking should be done on the premises with the exception of roti skin.
- Contestant booths are subject to a random inspection at any time.
